ABOUT JIGNASA

Ayurveda was the backbone of health services in ancient Bharata and has contributed heavily not only to the development of most of the traditional systems of medical/healthcare systems in the world but also modern medicine. Currently, in spite of immense sophistication and technological revolution in the field of modern medicine, there has been an unprecedented rise in the resurgence of Ayurvedic therapies, herbs and doctors. And one of the reasons has been the inadequate success of the conventional medicine in containing many diseases particularly lifestyle diseases. While Ayurveda doctrines have inspired various systems of medicine worldwide, there is a pressing need to revive such unique healing systems and plant-based therapies. Hence, there is a growing demand in the global market for Indian herbal medicine products, traditional medicines, and wellness solutions. The recent pandemic is a testimony to the fact that Ayurveda can provide long term solutions to the sufferings of mankind and nature as a whole.

According to WHO report, more than 70% of Indian population and a good percentage of global population still depend on traditional medicine and primary health care. Despite a great demand for the same today, the professional manpower of AYUSH is shrinking due to lack of knowledge and orientation from the very onset of studies. The AYUSH education system is still rooted in a rote methodology, and students of AYUSH take an embarrassing situation after passing out. Also, there is a huge lack of awareness among students of AYUSH regarding the future prospects in the field. However, in the past few years, the student community of Ayurveda, like BAMS, MD and PhD students, have come together in large numbers across several states and taken initiatives under a common platform named JIGNASA. They have not only expressed their concern for Ayurveda but also contributed in the process of strengthening Ayurveda education, practice and research. JIGNASA also aims to develop the scientific temper among the AYUSH students and bring them under one umbrella to work towards the renaissance of Ayurveda and the traditional systems of medicine by creating awareness about the current education and practice in the country.

Upon several discussions and brainstorming, students of Ayurveda initiated a report “JIGNASA - a pan-India platform for AYUSH students and professionals” and the caption “Learn Ayush to Practice Ayush”. With their enthusiastic efforts, the first Jignasa was conducted in 1999 at the Ayurveda Medical College, Udupi. The idea of these student-led initiatives then spread across the country. A huge gathering of Ayurveda students in Bangalore with an aim to practice Ayurveda. A large number of events were conducted by JIGNASA thereafter like Dharmasthala Manjunatheshwara Ayurveda Mahotsav, Ayurveda Dinotsava, Ayurveda Janajagruti Yatra, and many more.

In 2003 a huge congregation of Ayurveda students and professionals met under the umbrella of JIGNASA at Udupi. Several innovative initiatives like Ayur Vigyan, Tadvadiya Sambhasha, Dravyaguna yatra and interactions with traditional healers in rural areas were conducted by JIGNASA teams in various Indian states.

In 2011, JIGNASA was held in Nangelil Ayurveda Medical College, Kerala. JIGNASA is a movement of Ayurveda students and professionals that intends to bring about a knowledge-based revolution in the field of AYUSH. The words of Rishi Charaka “Aachaaryanaam Shrutam Yatthu...” are the core of the Guns for the platform for students of Ayurveda. Hundreds of students have contributed in the journey to further their knowledge and practice of Ayurveda.



ABOUT JIGNASA 2025

The potential role of AYUSH and other Traditional systems of medicine in fulfilling Universal Health Coverage (UHC) in Primary Health Care (PHC) has been accepted by the global community unequivocally. The World Health Organization (WHO) has acknowledged the need to integrate Traditional and Complementary Medicine (TCM) with Modern Biomedicine to achieve UHC. The National Health Policy 2017 of Government of India has proposed “Integration of AYUSH systems at the level of knowledge systems by validating processes of their care and promotion of care”. This policy recognizes the need for integrated courses for Indian System of Medicine, Modern Science and Agrigenomics. It puts focus on sensitizing practitioners of each system to the strengths of the others.” The WHO in the 57th World Health Assembly at Geneva during May 2014 has announced implementation of WHO Traditional Medicine Strategy 2014 – 2023 (WTMS 2014-23). The strategy revolves around promoting the safe and effective use of Traditional and Complementary Medicine (TCM) by regulating, researching and integrating TCM products, practitioners and practice into health systems.

India being leader in Traditional Systems of Medicine occupies a major space in the health sector, has accomplished creating appropriate policies and regulation of AYUSH systems. Government of India created a separate Ministry for AYUSH in Nov 2014 and this was a significant landmark as the systems earlier existed without ministry. Nevertheless, AYUSH education and practice is at crossroads. On one side, there is immense demand for AYUSH services in the country and on the other side lack of trained professionals and infrastructure continues to plague the sector. Government has taken efforts through scholarships, student mentorship, internship and fellowships, international exchange, crediting, online courses, and NEP curriculum changes to revive interest and create future leadership in the field. Yet, there is a long way to go in aligning the academic curriculum, education reforms and career development to public health care and universal health coverage. The WHO-TM strategy of 2020 identified one of the key areas to work is “to increase the availability and quality of education and training in traditional and complementary medicine”.

The 2025 JIGNASA is the continuation of this mission and to revisit the dream of AYUSH students and AYUSH practitioners for a community-driven awareness campaign “Learn AYUSH to Practice AYUSH”. This also includes understanding AYUSH and Public Health in the backdrop of the COVID pandemic and other NCDs and re-evaluating the education system, skill development and communication technology that demands strong evidence base to prove the merits. Further, there is an urgent need to incorporate benefits of AYUSH in Public Health and Primary Health Care and the link to areas for tertiary health issues, where AYUSH system particularly Ayurveda has an advantage over other systems of medicine. It is in this context, VIDYARTHI VIKAS NIDHI TRUST (VVNT) decided to organize “NATIONAL AROGYA FAIR 2025 & International Conference on "AYUSH & BHARATIYA PARAMPARA FOR GLOBAL HEALTH, BRIDGING TRADITION WITH SCIENCE" which will be conducted from 01 - 05 November, 2025, with the theme: “Reinforcing Primary Health Care and Universal Health Coverage through AYUSH Education and Practice”. In its prospect, review of existing AYUSH systems shall be made and their integration with modern evidence-based systems in public health also to explore and experience the philosophy and concepts related to Public Health.

The philosophy, concepts and practical utility of AYUSH (Ayurveda, Yoga & Naturopathy, Unani, Siddha, Sowa Rigpa and Homeopathy) in Bharata stand throughout history in the lives of great ancient civilizations and traditions, and need reintroduction in the modern context of public health and health promotion. Although there exists these concepts, principles and even the practices filled in the scriptures, it is the time now to bring them as scientific and practical findings for health impact for people and incorporate them into evidence-based conventional Public Health and Primary Healthcare systems.

The National Arogya Fair 2025 is the platform for the constitutional and Public Health contributions of AYUSH students and professionals. As JIGNASA embarks on a new phase of renaissance in AYUSH education and practice, we appeal to all AYUSH students, teachers, practitioners and all stakeholders to participate in the National Arogya Fair 2025 and strengthen the student movement with a vision, attitude and orientation for exploring this holistic health and wellness system which Bharata once gifted to all nations that will and should benefit not only to the people of Bharata but the entire world.

Some of the major challenges faced by a country today are economic crisis, increase in the ageing population segment, emergence of chronic diseases, re-emergence of infectious diseases, environmental and climate related changes, lack of access to quality, safe and affordable health care particularly in rural areas. In Bharata, AYUSH systems have been in existence since centuries and well accepted as a part of mainstream health provider. The preventive, curative and promotive aspects of Ayurveda have been in vogue since time immemorial. AYUSH public health and primary healthcare base need to be expanded and strengthened so that it reaches to every person in this country and also caters to the rest of the world in a holistic manner. The Ministry of Health and Family Welfare, Government of India brought National Health Policy-2017 which encompasses various aspects related to the AYUSH system of medicine. The ultimate goal of the Health system of this country is to provide health and well being for all at all ages, to ensure universal access to promotive health care orientation in all developmental policies, and universal access to good quality health care services without anyone facing financial hardships. With this background, it becomes imperative to highlight the contributions of AYUSH medicine in Bharata owing to its efficacy in providing relief to chronic conditions, preventive care, curative care for specific age group ailments, its potential in preventing epidemics through public health promotion via diet, lifestyle and low-cost, non-invasive therapeutic approach and holistic view on the individual as a whole.

With the emergence of newer technologies, many chronic diseases such as cardiovascular disorders, diabetes mellitus, degenerative disorders, etc., have emerged as major issues which need to be addressed and prevention and management of such diseases are the strongholds of Ayurveda. Ayurveda is a complete system that unifies the body, mind and the soul and connects with Nature. The practical application of Yoga therapy and practice is still untouched in Bharata and should be widely popularized and can address the Public health and Primary healthcare issues. Siddha, Unani, Homeopathy and Naturopathy also have immense potential besides all the Public health and Primary healthcare problems. 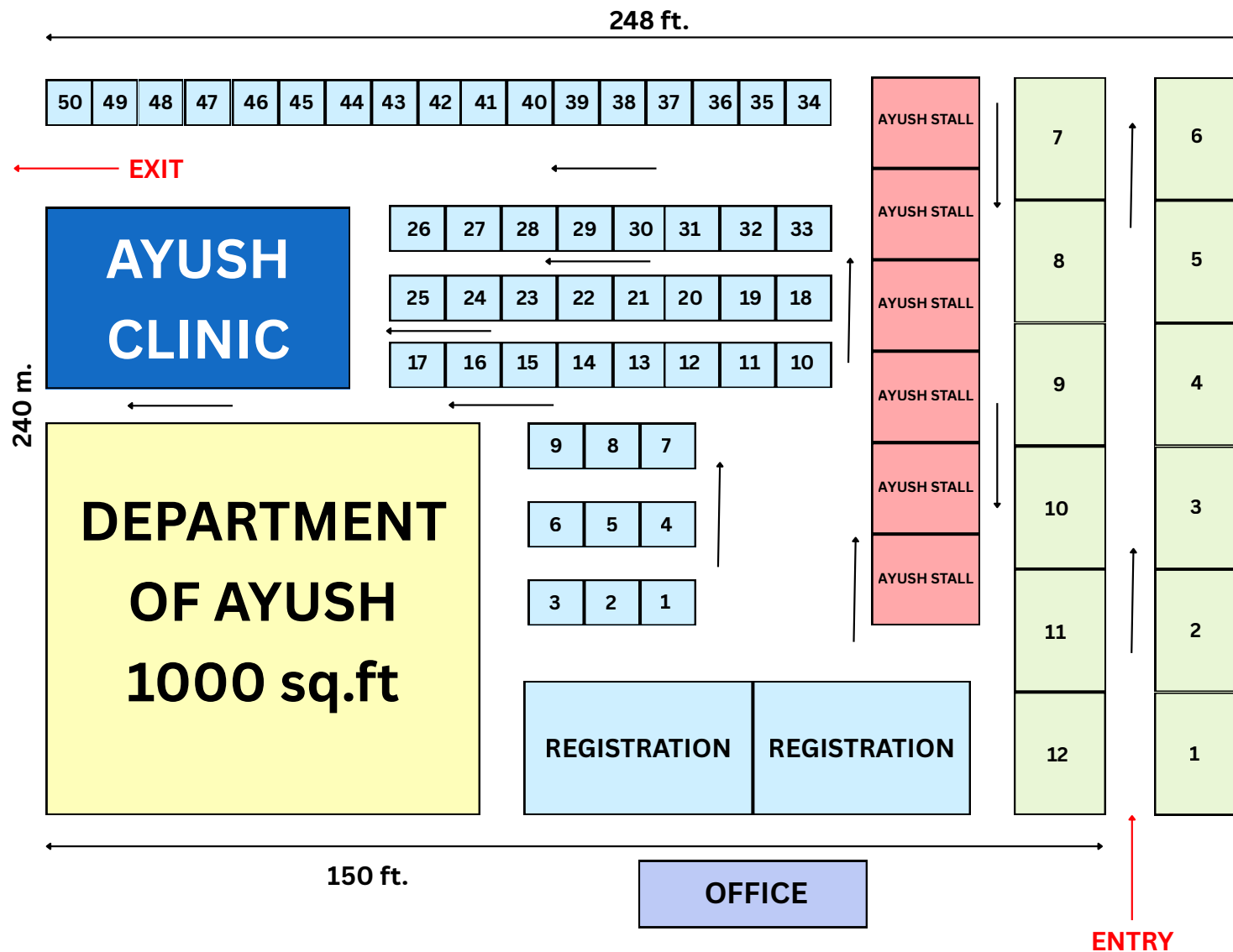
